## 2. Hazards Identification

**Emergency overview** Irritating to skin. Prolonged exposure may cause chronic effects.  
**Potential health effects**  
**Routes of exposure** Inhalation. Ingestion. Skin contact. Eye contact.  
**Eyes** Contact may irritate or burn eyes.

## 4. First Aid Measures

**First aid procedures**  
**Eye contact** Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Get medical attention immediately.

## 5. Fire Fighting Measures

<b>Flammable properties</b>	Do not use forced stream as this could cause fire to spread.
<b>Extinguishing media</b>	
<b>Suitable extinguishing media</b>	Water. Water fog. Foam. Dry chemical powder. Carbon dioxide (CO <sub>2</sub> ).
<b>Unsuitable extinguishing media</b>	Do not use a solid water stream as it may scatter and spread fire.
<b>Protection of firefighters</b>	
<b>Specific hazards arising from the chemical</b>	Fire may produce irritating, corrosive and/or toxic gases. H <sub>2</sub> S
<b>Specific methods</b>	In the event of fire and/or explosion do not breathe fumes. In the event of fire, cool tanks with water spray. Use water spray to cool unopened containers.

<b>Personal precautions</b>	Ventilate closed spaces before entering them. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing.

<b>Methods for containment</b>	ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Prevent entry into waterways, sewer, basements or confined areas.
<b>Methods for cleaning up</b>	Dike far ahead of spill for later disposal.  Never return spills in original containers for re-use. Shovel the material into waste container.

## 7. Handling and Storage

<b>Handling</b>	All equipment used when handling the product must be grounded. Do not get this material in contact with eyes. Avoid contact with skin. Do not use in areas without adequate ventilation. This product is a mixture of water and asphalt. Heating to temperatures above 190°F can cause the water portion to boil, causing excessive frothing resulting in hot asphalt overflow. Avoid prolonged exposure. Hydrogen sulfide (H <sub>2</sub> S) may be given off when this material is heated. Do not depend on sense of smell for warning. Wash thoroughly after handling. Avoid release to the environment.
<b>Storage</b>	Keep away from heat and sources of ignition. Prevent electrostatic charge build-up by using common bonding and grounding techniques. Store in a well-ventilated place. Keep container tightly closed. Keep away from food, drink and animal feedingstuffs. Keep out of the reach of children. Use care in handling/storage.
